## **Together, We Will.**Launch of New Renal and Cancer Plans



On March 30, Cancer Care Ontario launched the Ontario Cancer Plan (OCP) IV and Ontario Renal Plan (ORP) II.

These plans provide a comprehensive roadmap for the way Cancer Care Ontario, health care professionals and organizations, cancer and renal experts, and the provincial government will work together to develop and deliver cancer and renal services over the next four years.

The cancer and renal plans share several commonalities, including three key themes — patient centred care, integrated care, and improved patient access. Built on the foundation of past plans, the OCP IV and ORP II expand on progress achieved to date, incorporating lessons learned to further drive quality and accountability. This solid foundation has provided us with the chance to reflect on how we can continue to build on

our success, including how we engage with partners.

In the coming months, the South West Regional Cancer Program and the South West Regional Renal Program will be working to develop regional plans that reflect the OCP IV and ORP II priorities, and will in turn signal the work of our regional cancer and renal programs. ## Cancer System Quality Index Shapes Ontario's World-class Cancer System



On May 20, the Cancer Quality Council of Ontario released the results of the 2015 Cancer System Quality Index (CSQI), an interactive tool used to measure the performance of the cancer system in Ontario.

The CSQI is a quality improvement tool that identifies gaps in the cancer system and drives improvement through regional, provincial, national and international benchmarking. This is the sixth year that the tool has showcased benchmarks for Ontario's performance. The CSQI evolves year over year and informs Cancer Care Ontario's overall action plan, helping to determine priorities and allocation of resources.

The CSQI wants to ensure that efficiency within the system can be measured and better understood. This will ultimately add value to the cancer system and improve the overall patient experience.

"Results from this year's CSQI demonstrate that Ontarians can continue to be confident in

their cancer system." said Michael Sherar, President and CEO, Cancer Care Ontario. "We will use the 2015 results to continue to drive excellence through the many initiatives already underway across the cancer journey."

The CSQI 2015 includes a total of 34 indicators spanning the cancer journey from screening to survivorship as well as end-of-life care, along with several measures related to cancer prevention.

#### **Tools for the Journey**

Palliative care is not a common term for First Nations, Inuit and Métis (FNIM) communities. As a health care provider, a culturally competent approach to palliative care means supporting the spiritual and cultural beliefs of your patients. When interacting with First Nations, Inuit and Métis communities, the ability to understand, appreciate, and respond to their needs can have a substantial impact on the patient experience.

To help support caregivers when interacting with FNIM communities, the Aboriginal Cancer Control Unit of Cancer Care Ontario produced a resource toolkit called "Tools for the Journey: Palliative Care in First Nations, Inuit and Metis Communities." The toolkit contains a series of brochures on palliative care along with a reference binder of materials. The information and resources in this toolkit were developed in collaboration with FNIM communities and organizations.

The series of brochures includes six topics:

- Understanding the Diagnosis for Patients and Caregivers
- Teachings to Support Grief and Loss
- What to Expect: Making Decisions and Plans
- Taking Care of Your Loved One
- Working Together
- Who to Talk to for Support


Palliative care is one of the priorities identified in Ontario's Aboriginal Cancer Strategy II. The strategy commits to directly engage with First Nations, Inuit and Métis leaders and health networks in a community-based and holistic way to reduce cancer in First Nations, Inuit and Métis people, and to ensure those with cancer live longer and better lives. ## Making the Healthy Choice the Easy Choice

Individual efforts to lead healthier lives only take us so far in our goal of reducing the impact of cancer and chronic disease. There is strong evidence that system-level initiatives such as healthy public policy and community-wide programs are more effective in reducing the prevalence of modifiable risk factors.

Cancer Care Ontario has launched the inaugural 2015 Prevention System Quality Index (PSQI), a report that measures the effect of system-level initiatives in cancer prevention and early detection in Ontario by analyzing 15 indicators spanning seven domains: tobacco, alcohol, healthy eating, physical activity, environment, ultraviolet radiation and cancer screening. The 2015 PSQI report discusses current programs and policies of significance in these areas and highlights gaps that exist.

The findings of this report indicate that while progress is being made in some areas, a significant need remains for improved cancer prevention efforts across



the province at a public policy and system level. Over the past decade, the prevalence of risk factors and exposures in Ontario have shown little or no improvement. The PSQI report supports the development of broad-scale programs that will help with cancer and chronic disease prevention.

The PSQI report, based on the latest evidence, will evolve in the coming years to provide a comprehensive annual report on Ontario's efforts in cancer prevention.

#### **Latest Updates**

**New OBSP Policy: Screening Women over 75** - The Ontario Breast Screening Program (OBSP) recommends screening with mammography for women at average risk who are between the ages of 50 and 74.

Women aged 75 years and older who wish to be screened through the OBSP must be referred by their primary care provider. Women over the age of 75 are encouraged to speak to their primary care provider in order to make a risk-appropriate decision about whether or not to screen. This approach aligns with the recommendations made by the Canadian Task Force on Preventive Health Care. If a woman chooses to be screened and is referred by her family physician, she will receive result letters from the OBSP. She will not receive recall letters or invitation letters.

**The New Interactive Screening Activity Report**- The Screening Activity Report (SAR), developed by Cancer Care Ontario (CCO), is a tool to support physicians in improving their cancer screening rates for breast, cervical and colorectal cancer screening.

CCO has recently enhanced the SAR to provide a more interactive experience. A physician (or delegated office staff member) can now quickly drill-down to the specific cancer screening information she/he is looking for. The modifications make the SAR reports more user-friendly and efficient. To learn how easy it is to navigate the SAR watch the quick support videos at www.cancercare.on.ca/SAR.
